NOTIFICATION

Delhi, the 25th December, 2025

F. 223/SDM-II(HQ)/Land/2025/285.—In supersession of all previous notifications on the subject and in exercise of the powers conferred by sub-section (1) & sub-section (10) of section 3 read with section 4 of the Delhi Land Revenue Act, 1954 (Delhi Act 12 of 1954), and all other powers enabling him in this behalf, the Lt. Governor of the National Capital Territory of Delhi is pleased to create, with immediate effect, thirty-nine (39) Sub-Divisions/ Tehsils and thirteen (13) Areas in the National Capital Territory of Delhi, which shall be co-terminus with the Twelve Zones of the Municipal Corporation of Delhi and one NDMC & Delhi Cantt Area, as existing on the date of this notification or as may be reorganised from time to time.

Further, in exercise of the power vested in him under section 10 of the Delhi Land Revenue Act, 1954 (Delhi Act No. 12 of 1954) and in supersession of all previous notifications issued in this behalf, the Lt. Governor of the National Capital Territory of Delhi is pleased to create and form Thirty Nine (39) Sub-Divisions/Tehsils by altering the limits of the existing Sub-Divisions/Tehsils in Delhi. Each Sub-Division/Tehsil shall be known by the name specified in the Column (3) of the Table-I and shall be placed under a separate Revenue Assistant.

I. For the purpose of Revenue Administration only: For maintenance of land records and for all purposes under the Delhi Land Revenue Act, 1954, and other connected laws, the revenue village shall continue to be the basic unit. The jurisdiction of each Sub-Division/Tehsil shall extend to the areas under the revenue villages specified against the Sub-Divisions/Tehsil in Column (4) of the said Table-II.

II. For the purpose of General Administration: The Municipal Corporation of Delhi (MCD) Wards shall henceforth constitute the basic unit of general administration. The jurisdiction of each Sub-Division/Tehsil shall extend to the areas under the MCD wards specified against the Sub-Divisions/Tehsil in Column (4) of the said Table-III.

This notification shall come into force with immediate effect.
